







A Listening Session for National Apprenticeship System Enhancements

On January 4, 2023, the Office of Management and Budget's (OMB) Fall 2022 Regulatory Agenda published in the Federal Register, with an entry for proposed rulemaking, Regulation Identifier Number (RIN) 1205-AC13: National Apprenticeship System Enhancements.

In support of the proposed rulemaking, The Office of Apprenticeship is hosting a 90-minute listening session to hear ideas from the public on what policies and practices could serve to strengthen the National Apprenticeship System.

- Modernize the National Apprenticeship System;
